## **RRC Extends Successful Orphan Well Plugging Streaks**

The Railroad Commission's **State Managed Well Plugging Program** successfully plugged 1,012 orphan wells in Fiscal Year 2024, exceeding our goal of 1,000 wells! This marks the eighth consecutive year in which the RRC has surpassed its legislative performance measure.

"The RRC continues to be a national leader in addressing orphaned wells," said Danny Sorrells, RRC Deputy Executive Director. "Our extensive well plugging experience dates to 1984, and elements of our program, such as a prioritization system that ensures high-risk, high-priority wells are plugged, have

been copied by other states. The design of RRC's plugging program and our dedicated staff help us quickly work to protect groundwater around the state."
